Our visionary founders believed that only doctors could truly understand the unique challenges of the profession. They introduced an ethos of *doctors for doctors*, a principle that has guided us to this day.

MDA National crafted a structure of support and security tailored to Australian doctors. This spirit ensured that generations of medical professionals could practise with confidence, knowing that their association would always be there to safeguard their reputation and peace of mind.

We have set ourselves apart by continuously standing beside our Members with unwavering, personalised support.

Together, we look forward to another century of service to our Members, as they help shape the future of medical practice for the generations to come.

# **Our history**

#### From humble beginnings to becoming strong and independent

First formed as the Medical Defence Association of Western Australia (MDA WA), our story began on the 30 July 1925, when a group of 24 doctors gathered at Perth Hospital (known today as Royal Perth Hospital), sharing the vision to protect their peers from litigation and promote good medical practice. The initial membership consisted of 71 doctors. The group elected the first Chair, Dr John Joseph Holland, who is also considered the founder of the organisation.

From this humble beginning, our purpose has remained clear: to support Members when they need it, safeguard their professional integrity through a range of services, and promote the quality of the healthcare they deliver.

MDA WA was built on collaboration and compassion, with doctors working together and, through its affiliation, drawing from the experience of the Medical Protection Society (MPS) in the UK to create a system uniquely suited to Australia's medical professionals.

Throughout the 20th century, we grew steadily, expanding our capacity to provide personalised medico-legal assistance and dedicated support to doctors across Western Australia.

In 1975, a new chapter unfolded when local accountant Peter Forbes began his remarkable journey with MDA National. Appointed Managing Director and CEO, Peter's visionary leadership over four decades transformed the organisation, steering it from a local association to one of Australia's leading medical defence organisations.

Born in Windsor (NSW), Dr John Joseph Holland (1876 – 1959) moved to Perth to help alleviate the shortage of doctors in the city, having taken on a range of roles including at the St John Ambulance. He was engaged in helping patients in remote areas and supporting the development of medical education. Dr Holland received numerous awards throughout his career. He is considered the founder of MDA National and was the first Chair.

In 1989, we parted ways with MPS and became independent. This bold move marked a significant shift, allowing us to manage our own medical indemnity coverage and better serve our Members.

By 1992, we had established our own insurance company and refined our structure to support an expanding membership base.

In 1997, we became Australia's first Medical Defence Organisation (MDO) to adopt claims-made policies, embracing greater transparency and providing a clearer understanding of liabilities and risks.

#### MDA WA becomes MDA National

After more than seven decades of operations, in June 2000, MDA WA became MDA National. Not just geographic growth, this expansion enabled the organisation to become part of a national MDO structure. The foundation of MDA National reflected the organisation's commitment to ensuring that all doctors, regardless of location, had access to the same high level of support and protection.

Under A/Prof David Watson's chairmanship, the transition to a national organisation brought many positives, including the implementation of risk management programs and strategies, continued progress towards compliance with APRA reforms at the time, and an increase in membership.

#### Navigating the medical indemnity crisis

The early 2000s brought significant challenges as the medical indemnity industry faced a crisis with the collapse of a major medical indemnity insurer in the eastern states. This collapse was linked to the liquidation of a large Australian insurer, which provided services to many MDOs at the time.

Our strong leadership predicted the turmoil in the insurance sector which enabled MDA National to be well-prepared to navigate this period. Our solid financial management allowed us to thrive and ensure that Australian doctors continued to have access to the professional indemnity insurance they required. MDA National rapidly opened offices across Australia, offering doctors a safe alternative for support and indemnity insurance.

#### What our next century holds

In 2024-2025, MDA National took significant steps towards future-focused priorities. These include a major systems' transformation to enhance services for our Members, and a deepened commitment to our Environmental, Social and Governance (ESG) goals, marked by the submission of our REFLECT Reconciliation Action Plan (RAP) and the strengthening of key social impact partnerships. A century on, our commitment to supporting the medical profession is as strong as ever, and continuously evolving. While staying true to our founding purpose of standing beside doctors and supporting the delivery of quality healthcare, we are constantly adapting to meet the changing needs of our Members and the shifting healthcare landscape.





# When our Members tell the story



In the 1980s, we started to get a bit anxious about medical-legal issues, and all our journals would have a section dedicated to medico-legal cases. Then there was also the time of the great escalation of cases in America in the early 1990s. I joined the MDA WA Council in 1996 while working in radiology, at a time when there was a rise in medico-legal cases for missed breast cancer and for alleged birth injuries resulting in damaged babies. My subspecialist interests were womens' imaging and paediatrics. I thought it would be important for someone with an understanding of those areas to bring more expertise to the Council.

They [MDA National] were interested in recruiting a more diverse range of skill sets. Initially, my interest was in the cases, but after I'd been on the Cases Committee for a while, I became interested in the other aspects of the business and started developing business and managerial skills. These were essential to be an effective Director and taught me a great deal about areas that were not just medical. The Member interviews we conducted at MDA National were helpful to me in learning about personnel management and having difficult conversations. I was able to take this experience into the medical workforce, managing trainees who were not performing as well as they should, or who were under stress or impaired in some way. I was working about 15 to 20 hours a week for medical defence. The skills I gained from MDA National were really valuable to me in my medical career.

# Financial summary

The MDA National Group reported a profit after tax of \$15.9 million for the year ended 30 June 2025 compared with \$25.9 million for the prior year.

The Group remains financially strong and is in the midst of a major transformation program that will bring new people and technology capabilities to better position MDA National for the future. The investment will enable us to provide our Members with customised and more personalised service as well as drive efficiency across the business. Regulatory expectations are continually increasing and the need to have in-built controls and well-integrated systems to be able to meet our obligations has become a necessity. Whilst the new systems are being implemented, MDA National has seen an inevitable increase in our operating cost base. As the benefits of the investment is realised over the next few years, we anticipate the operating expenses to fall and stabilise.

As a Mutual, we're mindful of how we use our Members' funds. We operate with a lean workforce, continuously investing in our people to help them grow and develop the skills needed to meet Members' changing needs. Our *Members first* approach guides our staff and shapes everything we do.


MDA National's claims experience has stabilised in the last year with some changes made in the approach to the management of claims. Consistent with other insurers in the sector, we are impacted by societal factors such as rising cost of claims, secondary psychological injury and nervous shock claims which increase the overall dollar value of claims paid for any one incident.

#### Investment strategy

Our investment strategy remains prudent with a large proportion of our investments in Term Deposits and Bonds, ensuring liquidity and ease of access to funds, and reducing the volatility arising out of the investment portfolio. It is inevitable that inflation and interest rate movements will have an impact on our investment portfolio, but the philosophy is that we invest for the long term whilst taking necessary possible actions to minimise the impact of the volatility.

The MDA National Group retains a strong capital position as required by our prudential regulators. Our capital management strategy remains unchanged, and capital is there first and foremost to ensure that we have sufficient funds to pay Members' claims today, and in the future, and to fund the growth of the organisation. We are excited about the opportunities offered through our new system capabilities and how this will help MDA National make positive advancements as we step forward into our next 100 years.

# President's report

Dear colleagues,

It is with great pride that I write to you as President of MDA National, celebrating not only 100 years of continuous service to Members, but an auspicious centenary year. The organisation is unrecognisable from the one founded so modestly by a small number of doctors in Perth in 1925. The support I've had throughout my career has been invaluable to the medical practitioner I've become.

Back in September 2003, I was busy studying for my MRANZCOG examinations. That month at Randwick Racecourse, around 4,000 doctors met in a crisis meeting to demand urgent reforms to the medical indemnity industry. Members of MDA National were not asked to pay the 'call' that was potentially financially crippling to many of those doctors present that day. Our organisation's leadership had made the visionary reforms to provision for future claims, honouring the trust Members placed in us.

The Mutual Board of doctor directors that you elect work hand in glove with the Insurance Board, comprised of renowned experts in insurance, governance and the mutual sector. The two boards work closely with our CEO, Tim Plant, and the executive team. In turn they lead a team of managers and staff spread across Australia, delivering personalised services to doctors across every craft, at every stage of their career.

#### Celebrating our people

The reason that MDA National has been *trusted for generations* is that we have the expertise to spare our Members angst from the inevitable disruptions presented by the insurance and medical industries in which we operate. Medical practice is a complex world, but we deliver stability and assurance through the hard work and skills of our team.

Our staff are incredibly loyal to MDA National and our Members. Last year at the Staff Conference in Mparntwe (Alice Springs), I was able to honour longstanding members of our senior leadership team and staff who have worked for us for over 20 years – including Luke Thomson, Executive Manager, Underwriting & Insurance Risk Services, and Philippa Nash, Executive Manager, Cases & Advisory Services. I am grateful to them and every person in our team. I am grateful for the support of Terry Agnew, and before him, Steve Scudamore AM, who in turn have both chaired our subsidiary MDA National Insurance Pty Ltd with such skill and finesse.

#### Looking over the horizon

The leaders of MDA National have always been brave and looking over the horizon. We were ready when our competitors were not. The collapse of one of our major competitors and the ensuing indemnity crisis heralded in a much more stringent compliance framework and oversight from two separate regulators: the Australian Prudential Regulation Authority (APRA) and the Australian Securities and Investments Commission (ASIC).

Mix in some turbulence from the international reinsurance industry and the effect on the capital and bond markets from the bewildering geopolitics of post-Covid, and you might begin to imagine what a complex business we are operating. The seemingly ever greater intrusion of the medical regulator on our practices, the effects of the growth of consumerism and a culture of grievance and grumbling on both claims and complaints, the actions of plaintiff law firms, and the pernicious effect of social media on patient care all make our day to day lives more challenging.

Our organisation's leadership had made the visionary reforms to provision for future claims, honouring the trust Members placed in us.

#### The second hundred years

Many of you have had to rely on MDA National in the past to get you through a difficult period. I certainly have. For those of you who are fortunate enough to have not, we will be there for you when the moment comes that you do need us. We are strong and well capitalised, and we Members have the confidence that, no matter what challenges the future brings, MDA National will remain our stable, trusted partner.

We are excited to celebrate our 100-year milestone with Member engagement events planned in Adelaide, Brisbane, Melbourne and Sydney, culminating in a Gala Ball in Perth, where it all began. We raise our bat on completing our hundred. We have a wonderful story to celebrate, and an equal determination to continue to serve doctors, and in doing so, their patients, in our second hundred years.





# Doctors for doctors Expert guidance at the heart of everything we do

At MDA National, the ethos of *doctors for doctors* is a principle that defines us as an organisation. Doctors are best placed to understand the challenges, risks and realities of medical practice. Their lived experience ensures our services remain relevant, responsive and aligned with the evolving needs of the medical profession.

MDA National's role is not only to defend doctors, but to preserve their wellbeing. When a doctor is under pressure personally or professionally, there's the comfort of speaking to another doctor who understands the demands, the risks, and the human side of medicine. It's a peer-to-peer connection that fosters trust and understanding.

This is the way we have been supporting doctors through a century, with doctors standing beside doctors, offering expertise and support when it matters most. At MDA National, having doctors embedded across our core functions is an essential part of informing the high quality and personalised services we have been providing to doctors for 100 years. We take pride in operating as a member-owned mutual organisation, with a core vision of being the trusted partner of doctors delivering outstanding care.

#### The Cases Committee

Our Cases Committees (East and West) are structured to include highly experienced clinician Members from a wide range of specialties. This cross-specialty input enables in depth case analysis, helping to identify overlooked clinical context through comprehensive expert discussion. Members of the Cases Committee work in partnership with our Case Managers to provide clinical insights that inform complex claims. This Committee helps us manage claims and support doctors through some of the most challenging moments of their lives. The input from peers offers both practical and pastoral support, helping Members feel understood, protected, and empowered. When a complex case or investigation arises, the Cases & Advisory Services (CAS) team works closely with our committee members to ensure every Member benefits from specialty specific, contemporary clinical insight and collaborative problem-solving, throughout the life of the case.

In 2024-2025, we have been working on new guidelines for our Cases Committees to re-engage and expand their functionality. While we will continue to operate the two core Committees, this refreshed model will introduce a national committee structure alongside a broader and more diverse group of Members who will contribute their expertise to help us navigate complex cases. This approach marks a shift towards deeper Member involvement.

#### The Clinical Underwriting Committee

MDA National's Clinical Underwriting Committee has a primary role in ensuring Members receive fair, tailored cover that reflects their needs and is aligned with contemporary medical practice. Comprising doctor Members alongside industry experts, the Committee monitors developments in medical technology, treatments, and models of care, assessing both potential risks and opportunities to extend coverage where it is safe and appropriate to do so. In the Clinical Underwriting Committee, doctors help identify emerging risks and guide responses to high-risk matters.

Regular surveillance of emerging issues feeds into detailed analysis and discussion, with decisions made using an evidence-based approach, balancing sustainability with the need to protect Members from unnecessary risk. The Committee also works closely with other governance groups to make sure claims and complaints are assessed in context. In some cases, Members with higher claims histories receive targeted support, from intensive one-on-one guidance to broader educational programs, with the aim of helping them to continue practising safely and reducing future risk.



Whilst insurance and protecting the finances of our Member base are important, there's also a human factor. We're dealing with real people on the front lines, having real issues they have to deal with on a daily basis.



We provide tailored support, ensuring that when a doctor faces a notification, investigation, or negligence claim, they are protected legally, professionally, and emotionally. With a focus on proactive resolution, compassionate case management, and safeguarding reputations, our CAS team works tirelessly to protect Member interests while also supporting the integrity of the wider medical profession.

For more than a century, MDA National has stood beside doctors in moments of uncertainty. Our CAS team carries this legacy forward, providing expert, compassionate support to Members facing professional challenges such as notifications, investigations, or negligence claims.

## Early engagement

Our purpose is to protect Member interests, provide tailored support, and safeguard professional standing. Every case is approached with the understanding that while it may be routine for us, it is deeply personal and often distressing for the doctor involved. 

### When our Members tell the story

The story of Dr Emmeline Lee, an established radiologist, and Dr Harman Dev, a radiology registrar, reflects how mentorship and support between generations can make a difference in navigating the challenges of the profession.



Although they chose radiology for different reasons, both doctors share a commitment to women's health and the pursuit of balance in demanding careers. For Dr Dev, having Dr Lee as a mentor has provided reassurance and clarity at a time when she is transitioning from guided to independent practice. For Dr Lee, seeing younger colleagues embrace the profession reminds her of the value of passing on experience, particularly in subspecialties such as breast and obstetric/gynaecological imaging where the risks are significant.

Through initiatives like the Women in Radiology Group in WA and her academic role as Adjunct Associate Professor, Dr Lee has been in the vanguard of building an inclusive future for the profession. Dr Dev is seeing

the benefits of this progress in practice, with more young doctors getting exposure to radiology and understanding its aspects.

Alongside mentorship, both Members recognise the importance of a strong medical indemnity provider. Dr Lee has relied on MDA National for reassurance throughout her career, describing it as a vital support that has always been there when needed, while Dr Dev feels confident knowing she has the same protection in place as she steps forward in her profession. The story of Dr Lee and Dr Dev highlights the values that we continue to foster through the generations: mentorship, support, and trusted protection remain essential in helping doctors focus on delivering better care.

# When our Members tell the story



# Supporting Members with tailored education services

As we look forward to our next century of support, our approach to education is being shaped by a commitment to prevention, in response to the future of the medical landscape. Through our education programs, we help Members stay ahead of risk, practise with confidence, and focus on delivering quality care. We work closely with our CAS and Risk Services teams to provide educational resources to help Members mitigate professional risks.

In 2024–2025, our Education services delivered more than 40 programs designed to help Members proactively address the medico-legal challenges commonly encountered in practice. These programs are tailored to different stages of a doctor's career, offering practical guidance and real-world scenarios that reflect the realities of modern medicine. Additionally, MDA National launched an on-demand suite of resources for early-career doctors. The videos distill key professional and legal obligations, highlight common issues and scenarios, explain the framework around regulatory requirements and

professional obligations, and provide practical advice on how early-career doctors can manage these challenges.

#### Collaborating with industry bodies

We partner with several organisations to deliver content tailored to their teams and our Members, including workshops and presentations at industry conferences, webinars, events and in-house sessions for hospitals and health practices. Some of the organisations we delivered education activities in conjunction with are AMA (WA), RACGP, ACCRM and Street Side Medics. MDA National also regularly attains CPD accreditation with the RACGP, ACRRM, ACEM and RANZCO, and Members with these colleges benefit from MDA National reporting their completions directly to their colleges. In 2024-2025, more than 30 CPD accredited activities were available to our membership.

For Odette Brown, a Wiradjuri woman and medical student pursuing a degree at the University of Newcastle, medicine is a continuation of family legacy. As a child, Odette would find her mother's textbooks and be fascinated by the medical images. Dr Glenda Brown, also a Wiradjuri woman and Odette's mother, first became a nurse, then pursued medicine at the age of 56 while raising her daughter as a single parent. Watching her mother balance study, work, and parenthood while committed to Indigenous health has been Odette's greatest source of inspiration.

Odette was sponsored by MDA National to attend the Australasian Students' Surgical Conference (ASSC) in May 2025 in Sydney. Odette describes her mother's ability to build genuine relationships with patients, creating trust and space for difficult conversations. She recalls stories of her mother ensuring culturally appropriate end-of-life care, allowing families and ceremony to be part of the process. This approach, grounded in connection and respect, has deeply influenced Odette.

She already holds a degree in Aboriginal Studies and believes that it is in medicine where she can make the most impact. Although still early in her medical journey, Odette shows an interest in dermatology, having seen high rates of skin infections among children during her time in the Northern Territory. She worked in remote regions supporting early

childhood programs and facilitating health checks, seeing how simple interventions lift whole families. At university, she helped revive an Indigenous student group, secured free counselling, and ensured culturally informed support for her peers.

Sponsored by MDA National to attend the 2025 Australasian Students' Surgical Conference (ASSC), Odette was exposed to cardiovascular surgery, broadening her horizons and sparking new curiosity about surgical pathways. Looking ahead, Odette hopes to use her skills to support her community and contribute to culturally safe healthcare across Australia.

# Support for early career doctors

Our services remain relevant, accessible, and responsive through engagement and personalised support provided to Members, from early career doctors to specialist practitioners. In 2024-2025, we supported 15 national and alliance conferences, 13 state-based events, and a range of partnership meetings, including AMA Queensland initiatives, the Medical Careers Expo, Junior Doctor conferences, private practice seminars, and intern workshops. We also supported Women in Medicine breakfasts, leadership development programs, and skill-building events such as MedVAULT and the MEDCON workshop series. Our Business Development team continued to work closely with our strategic partners at the Australian Medical Association Queensland and Western Australia, the Australian Society of Ophthalmologists (ASO) and the Rural Doctors Association of Australia (RDAA), advocating for our Members and the medical profession.

# Junior Doctor programs and initiatives we've supported

We've been actively supporting Doctors in Training and Doctors in Specialist Training through a diverse program of specialty-focused education, general development initiatives, and networking opportunities. Across anaesthesia, ophthalmology, surgery, and physician training, we've worked on registrar orientations and teaching sessions, regional anaesthesia training, the ASA Part 3 Course, the ANZCA Trainee Dinner, Eye School sessions, surgical registrar journal clubs, leadership symposium, and interview preparation workshops.

Educational resources provided to junior doctors has covered a broad range of clinical topics from clinical documentation, consent and acute stroke calls to post-operative care, psychiatry, urology and palliative care, delivered across multiple hospital sites. We've also contributed to events such as the RACGP Education Weekend, New Fellows Networking Evening, the RACP Research Night, and national careers evenings, building skills, confidence, and connections across the profession.

#### Established our first ESG Committee



#### Our journey to reconciliation

MDA National's Reconciliation Action Plan (RAP) reflects our commitment to strengthening relationships, respect, and opportunities for Aboriginal and Torres Strait Islander peoples. As an organisation built on trust and service to the medical profession, we recognise the importance of contributing meaningfully to reconciliation and ensuring our values extend beyond our Members to the broader communities in which we operate.

It holds us accountable to embedding reconciliation within our business practices, and ensures that our engagement is consistent, respectful, and sustainable. It is not only the right thing to do, but also essential to creating a more inclusive culture for our employees, Members, and partners.

This journey started in 2016 when we offered the first MDA National Rural Health Bursary in partnership with RDAA. Since then, we've grown our support to organisations that promote wellbeing and access to healthcare for Indigenous communities. Other highlights include the development of a staff working group, and cultural learning opportunities such as our 2024 staff conference in Mparntwe (Alice Springs). Having submitted our draft REFLECT RAP, we are now preparing for its finalisation and implementation, guided by expert advice and input from Reconciliation Australia.

#### **ESG Steering Committee**

Replacing our former Corporate Social Responsibility Committee, we've implemented the ESG Committee to guide us through all our work in the sustainability and social impact space. This committee comprises of a diverse range of voices with different capabilities, offering insights into initiatives that have a wider impact. The committee currently meets on a quarterly basis and is key in ensuring MDA National continues to deliver on our sustainability goals, considering our Members, our people, and the communities and environments that we live in.

#### Supporting Indigenous health

We recognise that supporting health outcomes for Aboriginal and Torres Strait Islander peoples requires meaningful, community-led initiatives. Our partnerships with Binar Futures and the Indigenous and Remote Eye Health Service (IRIS) Program reflect this commitment, supporting practical solutions that are culturally safe, accessible, and responsive to community needs.

Binar Futures connects sport, culture, and health by creating safe spaces for Aboriginal and Torres Strait Islander people to access vital health checks while participating in sporting and cultural events. Binar Futures' Health Embassies provide on-thespot medical screening and direct referrals, helping to address chronic disease and other preventable conditions. In 2024-2025, more than 1,300 participants, ranging from approximately 3 to 75 years, registered across four embassies, with 126 abnormal results identified for medical follow-up.

Through our alliance with the Australian Society of Ophthalmologists (ASO), the IRIS Program, delivered by Vanguard Health, has been making an impact in reducing preventable blindness across remote and Indigenous communities.

By delivering cataract surgery and post-operative care directly to where people live, IRIS removes key barriers to treatment. This year, MDA National increased its funding support by 50%, enabling the development of new educational materials in Aboriginal languages to ensure patients and families understand the importance of after-surgery care. IRIS is now working towards a further 800 cataract surgeries across the Northern Territory within 24 months, improving sight and quality of life for hundreds of people.



# Extending our impact on healthcare delivery

In 2024-2025, we've welcomed Street Side Medics to our partnership portfolio, aligned with our goal of extending support to our communities. Street Side Medics is a not-for-profit organisation delivering free, GP-led, mobile medical services for people experiencing homelessness. Operating across New South Wales and Victoria, their fleet of mobile vans hosts weekly clinics, providing accessible healthcare to everyone without distinction. By partnering with Street Side Medics, we are uniting around a shared purpose: to extend care to vulnerable communities and ensure equitable access to healthcare.

Through this partnership, MDA National supports Street Side Medics not only by amplifying their impact, but also by contributing directly to their operations. Our support to Street Side Medics is seen in a range of areas, from helping to recruit volunteers to assisting with policy reviews, with the highlight being the delivery of the *De-escalation of Aggressive Customer Behaviour* course, delivered to volunteers via a collaboration between our Medico-Legal and Education teams. This partnership with Street Side Medics reflects the values of several generations of doctors who place community and social impact at the heart of their practise.

We are proud to support Street Side Medics and share the vision that patient-centred care extends beyond traditional settings and reaches those most in need, linking back to our purpose to promote better health for all

# Strengthening rural medicine

Since 2014, MDA National has proudly partnered with the Rural Doctors Association of Australia (RDAA) to strengthen support for doctors working in regional and remote communities. Both organisations have a commitment to addressing the challenges of rural practice with education, advocacy, and helping ensure that quality healthcare is available across Australia.

At the heart of the partnership is the annual Destination Rural Bursary, awarded to junior doctors with a passion for serving rural and remote communities. Recipients gain not only financial support but also invaluable opportunities to participate in workshops, conferences, and hands-on clinical placements. From 2016 to 2020, MDA National and RDAA offered the Rural Health Bursary, providing Aboriginal and Torres Strait Islander medical students with support for participation in rural clinical placements, health conferences, workshops,

or research projects. In 2021, this evolved into the Destination Rural Bursary, broadening its scope to support medical students and junior doctors with a demonstrated commitment to rural practice. Beyond the bursary, the partnership enables the delivery of a broad range of services, activities and benefits provided by MDA National, including access to our education events, co-promotion of events and promotional opportunities.

Over the past decade, this collaboration has celebrated the contribution of rural doctors and created pathways for young doctors to connect with rural practice early in their careers. In our next century of services, the partnership remains focused on encouraging, equipping, and celebrating doctors who bring vital healthcare services to rural and remote Australians.

What he values most about rural placements is the hands-on experience and the opportunity to work closely with colleagues and supervisors in a personal, supportive environment. These experiences have given him a clear vision of his own future in rural healthcare.

Looking ahead, he hopes to be practising as an ophthalmologist in regional Australia, bringing specialist care and advocacy to the communities that need it most.

# Members in the spotlight of our story




